

MedFiller Cookie Policy

This Cookie Policy explains how MedFiller and/or Nuanced Technologies Inc., as well as any of its parents, affiliates, or subsidiaries, (“MedFiller”, “Nuanced”, “us,” “our” or “we”) uses cookies and similar technologies on [MedFiller.com](https://www.MedFiller.com). This Policy should be read together with our [Privacy Policy](#).

MedFiller platform is designed for the exclusive use in United States and inaccessible from countries outside of the US. MedFiller, like most websites, relies on cookies to secure and support the functionality of our software system. At MedFiller however, we want to be transparent about the user information we collect and how we use it. This policy lists the various cookies that you might encounter on our website and their intended use and function.

We also want to assure our users (healthcare providers) and patients that we comply with HIPAA and all applicable US laws. Under no circumstances is health information shared or sold for marketing purposes.

What are cookies, my control options and how do I opt-out?

A cookie is a small text file stored on your device that allows web services to recognize you or your device. They are especially useful for sites to remember your preferences and session details. That way you can resume and pickup where you left off.

You can control how your system manages cookies in the user preferences of your preferred browser, and most browsers include a private browsing mode that does not retain cookies. Many jurisdictions require or recommend that website operators inform users/visitors to the nature of cookies they utilize and, in certain circumstances, obtain the consent of their users to the placement of certain cookies. Information about what any individual cookie is used for can be found in the list below.

Remember: use of any part of the MedFiller.com or the MedFiller forms platform is optional. Users are free to opt-out, use any cookie blockers, do-not-track plugins, VPNs, Private/Incognito mode on their browser to remove and disable all cookies at any given time.

Cookies used by MedFiller

MedFiller does not utilize third party tracking cookies for analytics, marketing, data sharing/selling or tracking user behavior across its own or third-party websites. In addition all cookies utilized on Medfiller.com are “strictly necessary” for function.

What are Strictly Necessary Cookies?

Strictly necessary cookies are essential for the basic operation of our website and cannot be disabled. These cookies enable core functionality such as user authentication, session management, security features, and load balancing. They do not collect personal information for marketing purposes, nor do they track your browsing activity across other websites. Because these cookies are required for the website to function properly, they are exempt from consent requirements under privacy regulations. Without these cookies, services our users require cannot be securely provided.

All cookies on both the unauthenticated portions of the MedFiller website (www.medfiller.com or medfiller.com) as well as the form related workflow parts of the website (e.g., forms.medfiller.com) are “strictly necessary” and cannot be disabled.

In addition, authentication and administrative security, cookies are only relevant to licensed MedFiller users (business clients of MedFiller such as staff at licensed health care facilities). End users, including patients and those browsing non authenticated parts of our website will not encounter such cookies.
